Payment, *when booth confirmed*, must be received no later than 40 days before the show date. Applications received with less than 40 days before the show must be accompanied with payment. Payment will only be accepted if we can place you into the show. Each show has to be a separate payment; please do not write one check for two or more shows.

**ALL ITEMS OFFERED FOR SALE MUST BE HAND CRAFTED.** Booths should be neat with all boxes, etc. well hidden. Additional storage for boxes is available in service areas. Tables should be covered and skirted. We wish to maintain the high standards set by previous shows. No Buy/Sell items allowed.

Please note that unlike bazaars and many mall shows providing an 8 ft table and no depth, our spaces provide 100 sq ft of exhibit space.

Full Attendance for the show is required to qualify for future shows.

Refunds will not be given if you cancel out of the show after payment has been received unless the spot gets resold.

Adventureland staff reserves the right to limit the number of similar items per category.
